ARCHIVIST'S REPORT

In the *Cheshunt and Waltham Mercury* (23-11-2012) it was announced that up to £411m. would be spent on widening the 15-mile stretch of motorway between junction 23 (South Mimms) to junction 27, for the M11. The hard shoulder would be converted permanently to a running lane and work would start as early as spring 2013 and take 2 years.

On the 11th June 1972 the *Enfield Archaeological Society* held its first field walk from New Cottage Farm, on the line of the proposed M25. At the S.W. corner of the now J24 roundabout was found the internal cast of a Belemnite fossil, preserved in flint. It was the first of the fossils found on the line of the M25 (J24 – J25) and is on display in the *Potters Bar Museum*.



Whereas the other erratic fossils from J24 and the erratic rocks from Theobalds Park Farm were brought to the North of the M25 by the proto-Thames and the glacier, Larvikite was not. A small sample of this rock was found at Theobalds Park Farm and like other samples from Hertfordshire and East Anglia it came from southern Norway. Exactly how it crossed the North Sea and joined the British ice stream is unknown.

I am grateful to Dan Ruge-Cope who loaned me his copy of *Most Secret War* by R.V. Jones, which when it was first published in 1970s caused great controversy, as no-one then knew of Bletchley and other secret WW2 establishments. There were references to Denys Felkin and the work at Trent Park, which subsequently moved to Latimer, in Buckinghamshire. Mention was made of No. 80 Wing, under Wing Commander E.B. Addison, whose headquarters were at Radlett. A branch of Military Intelligence was headed by 'Gubby' Allen, the England Cricket Captain. I was particularly interested in the Photographic Reconnaissance Unit at Benson, near Oxford, as my cousin's husband worked there. In all over 500 pages of interesting reading, and the last three final lines state, "will lead to the nation over-paying itself beyond its true income, and thus ruin. Until we learn that lesson we shall have lost the battle that we in the war fought so hard to win."

Just before Christmas I made one of my occasional visits to *Barnet Museum*, where I saw upstairs an exhibition on Barnet's Foundling Hospital, which had been researched and prepared by Yvonne Tomlinson. It was well-presented and very interesting. Barnet Museum, Wood Street, is worth a visit and it now opens Saturday a.m. and p.m., and two hours on Sunday afternoons, besides Tuesday to Thursday 2.30 - 4.30 p.m.

THE LIMERICK HOUSE SITE (Part 1)

Introduction


I contributed an article entitled '*The History of the Bridge House Site, Mutton Lane*' (The Newsletter Sept. 2011). When preparing another article on Limerick House I noted there were inconsistencies in the history of the Bridge House, which required further extensive research, in the Williotts Manor Court records, at The Guildhall, London.

Mr. H.J. Butcher (footnote 1) had produced an extensive list of owners of a property in Mutton Lane, commencing with Eleanor Phillips (2nd June 1743) and applied it to Limerick House. If he had referred to the map, which resulted from Edward Vickers' Survey of the Manor of Williotts, in 1745 (footnote 2) he would have seen the Phillips' property was more than likely near '*The Bridge House*' (see below).

From subsequent research using M.S.5454 Court Rolls Williotts, volumes 1-8 (from 1727) and the surviving rent lists of Williotts, it is possible to trace the owner/occupier of a property to before 1678. Also, for earlier dates there survives an Index to Court Rolls, in alphabetical order (M.S.5455), of which the earliest entries are 1488, 1490, 1503 etc.

The Early History

The earliest reference to the Limerick site occurs in a rental dated before 1678 (M.S.5521 Box A Bundle 2, No. 19) to a John Brock paying one shilling. Elizabeth Brock paid the rent in 1742, but the following year the rental noted, 'Elizabeth Rawlins late John Brock'. Her death was recorded in 1745, the same year as Edward Vickers' Survey marked Rawlins on the later site of Limerick House.



Elizabeth was succeeded by Daniel Staines, who pulled down part of his cottage (1746). William Farrer was admitted in 1750 and six years later he had not repaired his cottage. Did it fall down? In 1764 William Sandall enclosed about a rood of land late Farrow and in 1771 William Low (sometime *Lowe*) enclosed a piece of ground formerly William Fairways (footnote 3), which he added to his own adjacent cottage and land.

Footnotes

- 1 Mr. H.J. Butcher came to Barclays Bank, High Street,, Potters Bar, in 1914 and retired as manager in 1939. In the 1950s he wrote up his local history researches.
- 2 A copy of the 1745 map can be purchased from Potters Bar Museum for £1.
- 3 William Farrer/Farrow and Fairways are one and the same person.

William Lowe surrendered to John Bateman, Potters Bar, husbandman, in 1789, who was followed by Charles Whaley, Potters Bar, farmer, in 1795. His wife, Mary, died in 1807 and his son, Charles Whaley the younger succeeded the same year. The next significant date was 10th November 1823 when John Hopewell the younger, Chipping Barnet, grocer, surrendered to James Able Brett, St. Albans, innholder, as by then the one building had been divided into three. At the Court held 21st April 1851, by Deed Poll dated 7th May 1847, the other parcel (2 roods 5 poles) had been sold to the Great Northern Railway, for £375 (Williotts Manor Court 21-4-1851).

In his Will dated 8th March 1838 James Able Brett (Proved 19th February 1849) left the tenement he had lately erected on one piece leased to Francis Complyn of Hatfield, brewer, and the other to the use of Ann Hibbert, widow, who was living with him. She was to inherit providing she survived his wife, Susanna Brett, which she did, as Susanna died 7th September 1848. The third proclamation for the death of Ann Hibbert was presented 28th March 1853 and at the Williotts Court dated 9th April 1855 James Humphrey of Rustington, near Arundel, farmer, was admitted to the property. In December he surrendered out of Court to Richard Holmes the younger of Arundel. The Masters and Keepers of the Brewers and Lords of the Manor of Williotts for £61 8s (£61.40) agreed with Richard Holmes the younger to enfranchise the property, on the 11th October 1867.

SOUTH MIMMS CASTLE OBSERVATIONS 1977-79 A1(M) CECIL ROAD – ROESTOCK GREEN


On the 4th January 1979 ten soil samples from the Eocene infills indicated above were submitted to Mr. R A Ellison, at the *Institute of Geological Studies*. Samples (SM77/52) were round black Tertiary flint derived from Reading Beds. Five other samples were classified as Reading Beds or Reading Beds disturbed. Greencoated flints were characteristic of basal Tertiary Beds overlying Chalk, as did another sample being classed as Tertiary on Chalk. Borehole evidence (No. 101-104) on the line of the road to the south-west of the "castle", showed Reading Beds inter-mixed with glacial and post-glacial material. The conclusion on the evidence submitted confirmed the opinions expressed in 'Solution of the Chalk in the Mimms Valley, Herts' by J F Kirkaldy (Proc. Geological Association, Vol. 61, Part 4, 1950).

SM77/101 was a piece of ironstone and SM77/130 was an erratic derived from Bunter Pebble beds in the Birmingham area.

CONCLUSIONS

Evidence for the Outer Bailey

31st July 1977


Reading Bed Pebbles (SM77/52)



 The section above was observed to have a continuous line of Reading Bed pebbles above the ditch and on either side. To substantiate the observation Geof. Gillam, chairman of the *Enfield Archaeological Society* confirmed the line. On a contour map the lines showed a slight curve towards the castle, which indicated the line of a horizontal Eocene pipe. The ditch was confirmed as a natural pipe infill and therefore of a geological origin. Though of a geological origin that does not preclude a later surface use e.g. a field boundary. However, the problem of whether there was an Outer Bailey is still an open question. Around the castle site there were numerous horizontal, vertical and oblique pipes where the chalk had collapsed.


Distribution of Finds


When all the finds were plotted along a vertical section of the drainage ditch there were two distinct groupings from Post 54 - 68 (78 metres) and Posts 90 - 93 (17 metres), '**A**' (54-68) and '**B**' (90-93) on the map below.



In area 'A' sixty-seven sherds of pottery were recovered, of which twenty-four were Early South-Hertfordshire Coarseware (ESHER 1050-1200) as were twenty-four South Hertfordshire-Greyware (SHER 1170-1350). The possible origins of some were from Northolt, Oxford, Arkley, Pinner and the St. Albans' area. At Post 56, eight out of ten pieces of brick and eight out of thirteen pieces of tile were found, all very small. A fragment of an oyster, a large rabbit tibia, a sheep/goat scapula, three bone fragments, land snails and evidence of charcoal (SM77/90) were within this area. This evidence suggests medieval ware. Area 'B' indicates an earlier occupation site dating to the late Mesolithic/Neolithic periods.


On the graph below the vertical measurements are exact but in some cases horizontal records are noted between posts, e.g. 92-93, 90-92.





The most important result of the 1977-79 observations has been to prove the existence of human occupation on the site much longer than previously known. The castle site was used from Mesolithic times through the Iron Age period. The evidence for Roman occupation on the site remains slender.

LATER USE OF THE CASTLE SITE



Though the castle was possibly destroyed in about 1143 or later there has been some evidence of a subsequent use. During the construction of the A1(M) Cecil Road – Roestock Green, in April 1977, S. Castle discovered a small pit within the supposed outer Bailey (see 'A' to the left, Herts SMR 4835). He found 13/14th century pottery, iron slag fragments and burnt clay daub, also a decorated sherd and glazed jug rim. To the north-west of this find he also found a 12/13th century greyware body sherd from a ploughed field (see 'B' to the left, Herts SMR 4836). There is a record of three small silver coins but at the present time they are lost.

Dr. Kent, in his report to the *North Middlesex Archaeological Research Committee*, dated 21st February 1966 noted, "a jeton hitherto classified as later C15." Later in 1966 Dr. Kent (ed. Rutherford Davis, 1966) wrote, "The discovery of Fourteenth century material should also warn us against supposing that the disuse of the earthworks was immediate and complete."

Dr. Kent further wrote in 1968, "There is need for much more work on the castle. Virtually nothing is yet known of the Bailey, its buildings or defences, and the pre-castle phase of the site requires further elucidation."
